Sub: To lodge FIR against owner and driver of Mahindra 415 DLX (Red Colour) tractor having Engine No RJC4YBA1727, Chassis No MBNAAAVAPJRC01120 (without number plate) along with trolley (without number plate) loaded with sand approx 50-55 Cft.

Sir.

In producing herewith, 01 (One) tractor i.e. (i) Mahindra 415 DLX (Red Colour) tractor having Engine No RJC4YBA1727, Chassis No MBNAAAVAPJRC01120 (without number plate) along with trolley (without number plate) loaded with sand approx 50-55 Cft (ii) 01 piece old Iron made "Belcha" having iron butt and (iii) 01 piece iron made "Dhama" before you.

The nub of the fact in a nutshell is that today on 24.05.2021 at 09.45 hrs. I ASI Anirban Banerjee of Kashipur PS along with (i) C/1233 Lakhikanta Mahato and (ii) C/847 Uttam Hazra both of Kashipur PS, Dist - Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 745 Dtd -24.05.2021 and C.C No. 1123/21 Dtd. 24.05.2021. During my mobile duty, I received a tip off at 13.15 hrs. that some persons were loading one tractor with sand from the river bed of Dangra River near Manipur village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Dang a River and fled away from the spot. We rushed to the Tractor and detained the said tractor. We seasched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending Tractor. Hence, seized the above noted tractor along with trolley loaded with sand approx 50-55 Cft, 01 pieces old Iron made "Belcha" having iron butt and 01 pieces iron made "Dhama" and brought the said seized articles to Kashipur PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor vide along with the trolley and unknown others for investigation.
