Sir,

In producing herewith seized vehicles (Tractors) bearing Registration No. WB 55A 6511 attached with Trolley loaded with sand without any number plate. The fact of the case in brief is that on 09/05/2021 I along with C/1182 Santosh Kr. Mahata and C/2519 Arun Duley all of Kenda PS were on evening mobile duty. During mobile duty on 09/05/2021 at about 20.15 hrs. when we reached at Parbaid Village found that the above noted tractor was coming from Konapara side under Kenda PS towards Parbaid village. On seeing the Police party driver of the said tractor stopped his tractor in a distance and he fled away after keeping the tractor at Parbaid village. We searched the said tractor and found that the tractor was loaded with sand. Hence we waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor bearing Reg. No. WB 55A 6511 attached with Trolley loaded with sand approx. 100 CFT without any number plate under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging driver from my source and brought the tractor at Kenda PS. So it reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor having Registration No. WB 55A 6511 attached with Trolley loaded with sand.
