Sir,

In producing here with one accused person Kalipada Mahato (49) S/O Buddheswar Mahato of village-Sindurpur, PO- Jitujuri, PS Manbazar, District Purulia along with following seized articles viz-

- (1) 22 (Twenty two) Ltrs ID liquor within a Plastic Jarikane
- (2) 12 pieces plastic glass
- (3) 200 ML ID liquor collect from the Jarikane as sample

I S.I. Soumen Kumar Panda of Manbazar PS do here by lodged a complaint against accused namely Kalipada Mahato (49) S/O Buddheswar Mahato of village Sindurpur PO- Jitujuri, PS Manbazar District Purulia to the effect that today (18.05.21) at 16:05 hrs. I received a telephonic information from a reliable source that one Kalipada Mahato (49) S/O Buddheswar Mahato of village-Sindurpur, PO- Jitujuri, PS Manbazar District Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 587 Dtd 18.05.21. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/56 Bidesh Chakraborty, HG/1443 Uttam Kr Singh rushed to the spot for raid by Govt. vehicle. At about 17:05 hrs. myself along with force reached at Sindurpur village and held raid in the house of Kalipada Mahato and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Kalipada Mahato tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Kalipada Mahato (49) S/O Buddheswar Mahato of village-Sindurpur, PO- Jitujuri, PS Manbazar, District Purulia as per law and arrange for its investigation.
