Sir,

In producing here with 01 (One) arrested accused person namely Lakhu Hembram s/o Uday Hembram of Vill+PO+PS – Jamuria Dist- Paschim Burdwan.

I beg to state that today (24.05.2021) at 09:15 hrs. I was directed to find out whether the Pandemic situation of Covid - 19 has been implanted properly at Manbazar Market area or not. This refers to Manbazar PS GDE No-.773 Dtd. 24.05.2021 . Accordingly, I had been to market area side and found that, above person driving one bricks loaded truck having No- WB37B/3148 was coming towards Manbazar side from Indkuri more side. At Chowk bazaar detained the truck and after demanding, he failed to produce any document for plying such vehicle though there is specific direction of prohibition by the competent authority during such Covid – 19 pandemic situation.


As such I seized one Bricks loaded Truck loaded approx 3000 pieces Bearing registration no- WB 37B/ 3148 driven by Lakhu Hembram s/o Uday Hembram of Vill+PO+PS – Jamuria Dist- Paschim Burdwan, and bring the vehicle to PS and also arrested the above driver observing all formalities.

All the process was done in between 14:25 hrs to 14:55 hrs. After that I left for PS. On arrival at PS I typed this complaint by PS computer and submitted to OC Manbazar through duty officer ASI Subhendu Mahato for taking necessary action as per law.
