Sir,

In producing herewith one seized vehicle (Tractor) bearing registration No- WB 55B/3441 loaded with sand. The fact of the case in brief is that on 25.05.2021, I S.I. Sanjib Chatterjee along with force were on Special mobile duty vide Manbazar PS GDE No- 820 dated - 25.05.2021, on Manbazar Purulia Road (SH-5). During special mobile duty on 25.05.2021 at about 15:05 hrs. received credible source information that the above noted vehicle (Tractor) is coming from Samda village side towards Indkuri By-pass morh loaded with sand without valid paper. After receiving this information we proceeding towards Indkuri By-pass morh under Manbazar PS. found that the above noted vehicle (Tractor) was coming from Samda village side. On seeing the police party the driver of the said vehicle (Tractor) stopped the Tractor in a distance from Indkuri By-pass morh and tried to unload the sand, loaded in a separate trolley with said vehicle (Tractor). We rushed to the vehicle and the driver then fled away after keeping the vehicle Indkuri By-pass morh at 15:35 hrs. We searched the said vehicle and found that the vehicle is loaded with sand. I searched for any valid documents in respect of sand loaded in the Tractor as well as the valid documents in respect of that Tractor but nothing found. Hence I seized the vehicle (Tractor) bearing registration No- WB 55B/3441 loaded with sand measuring approx 100 CFT in a trolley under proper seizure list in presence of available witnesses duly signed them. Thereafter arranging a driver from my source I brought the said vehicle to Manbazar PS. As such there is every reason to believe that the driver and owner of the vehicle (Tractor) bearing registration No- WB 55B/3441 with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S - 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act. 1957.

Therefore, I pray before you that a case against the driver and owner of vehicle (Tractor) bearing registration No- WB 55B/3441 may kindly be started and arrange for its investigation.
