I beg to state that today (29.05.2021) at 12:05 hrs. I was directed to find out whether the Pandemic situation of Covid - 19 has been implanted properly at Manbazar Market area or not. This refers to Manbazar PS GDE No-.843 Dtd. 29.05.2021. Accordingly, I had been to market area side and found that, above noted persons driving 03 bricks loaded Trucks having registration No (1) WB 37C/2920 (2) WB 37D/3607 (3) WB37C/2066 were coming towards Pairachali road side from Bandwan road side. At Samda morh under Manbazar PS detained the Trucks and after demanding, their failed to produce any documents for plying such vehicles though there are specific direction of prohibition by the competent authority during such Covid – 19 pandemic situation.

As such I seized 03 Bricks loaded Trucks bearing registration No- (i) WB 37C/2920 loaded approx 3000 pieces (ii) WB 37D/3607 loaded approx 3500 pieces, (iii) WB37C/2066 loaded approx 3000 pieces, driven by (1) Hazrat Imam (25) s/o Muktar Sakh of vill- Barabani Kathaltola, PO +PS- Barabani, Dist- Paschim Burdwan (2) Bijay Pandit (35) s/o Basudeb Pandit of vill- Tarbangla PO+PS- Raniganjh, Dist- Paschim Burdwan (3) Rajkumar Tudu (33) s/o Kandan Tudu of vill- Panrodanga, PO – Nundih, PS- Jamuria, Dist- Paschim Burdwan and bring the vehicles to PS and also arrested the above drivers observing all formalities.

All the process were done in between 12:45 hrs to 14:35 hrs. After that I left for PS. On arrival at PS I typed this complaint by PS computer and submitted to OC Manbazar through duty officer ASI Subhendu Mahato for taking necessary action as per law.
