In producing herewith 04 (Four) arrested accused persons namely (1) Balaram Layek (58) S/O- Lt. Som Saren of Vill-Aradanga, PS-Neturia, Dist-Purulia and (4) Ramlal Kisku (30) S/O- Motilal Kisku of Vill-Muktipur, PS-Santuri, Dist-Purulia, I, SI Sujoy Kundu of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 10.05.2021 while I along with C/1303 Biswanath Majhi and C/1353 Atanu Ganguly both of Neturia PS as per direction engaged in anticrime day mobile duty in Neturia PS area, reference Neturia PS GDE No- 356 and CC No-1077/21 dated 10.05.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) Disaster Management Act, 2005 and arrange for its investigation.
