Sir,

With due respect I am to inform you that I, Sri Lalit Sen, WBCS (Exe.), Dy. Magistrate & Dy. Collector, currently posted at Purba Medinipur Dist. Hq., Tamluk and a resident of Vil & PO- Saltore, PS- Neturia, Dist.- Purulia (WB). Today from reliable sources I came to know that someone has hacked my Facebook Account. Using my profile picture, he/she is sending friend requests and demanding money from the persons who are very close to me. Some of these close persons informed me over phone regarding the same. From the chats that he has made with one of my known person a number has been found which dials as 7064052691 to transfer an amount of Rs. 20,000/- (Twenty Thousands) only via PhonePe. When he informed me, I instantly replied him (known person) that this is totally false and is not in my knowledge, Also requested him not to transfer any amount.

Under these circumstances, I am to request you to kindly look into the matter and take necessary action immediately.
