In producing herewith 04 (Four) arrested accused persons namely (1) Fatik Bauri (48) S/O- Dhanu Bauri of Vill-Kuthibari (2) Sk. Mustakim (20) S/O- Sk. Ujir of Vill-Namodigha (3) Prasanta Bauri (30) S/O- Nimai Bauri of Vill-Inanpur Majhi Para and (4) Sk. Tanahar (22) S/O- Sk. Ruf of Vill-Monpura all are under Neturia PS, Dist-Purulia, I, SI Kalyan Kumar Sakha 🔭 of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 11.05.2021 while I along with C/1140 Dayamay Mahato, C/939 Laltu Paul and C/480 Uttam Bauri all of Neturia PS as per direction engaged in anticrime day mobile duty in Neturia PS area, reference Neturia PS GDE No- 400 and CC No- 1086/21 dated 11.05.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Sarbari More at about 15:35 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Sarbari More but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) Disaster Management Act, 2005 and arrange for its investigation.
