Sub: Complain to start a specific case.

Sir,

In producing herewith 05 (Five) arrested accused persons namely (1) Md. Islam (35) S/O- Lt. Md. Aslam of Asansol Islampur, Master Para (2) Shambhu Kumar (36) S/O- Arjun Burnwal of Dildarnagar, Upar Para, Asansol (3) Vivek Burnwal (22) S/O- Shibu Prasad Burnwal of Namu Para, NRR Sarani, Asansol all under Asansol (South) PS, Dist-Paschim Burdwan, (4) Rajesh Shaw (24) S/O- Lt. Gopal Shaw of Barakar Hanuman Charai, Near Mama Plywood, PS-Kulti, Dist-Paschim Burdwan and (5) Tapas Bauri (30) S/O- Sricharan Bauri of Vill-Paharpur, PS-Neturia, Dist-Purulia, I, SI Sujoy Kundu of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 12.05.2021 while I along with C/1303 Biswanath Majhi and C/1353 Atanu Ganguly both of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 457 and CC No- 1098/21 dated 12.05.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Sarbari More at about 16:25 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Sarbari More but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
