In producing herewith 04 (Four) arrested accused persons namely (1) Joydeb Hansda (31) S/O-Lt. Babulal Hansda of Vill-Bakbari (2) Pabitra Tudu (23) S/O-Ruplal Tudu of Vill-Bakbari (3) Rabindranath Mandi (25) S/O- Sankar Mandi of Vill-Bhurkundabari and (4) Kalimuddin Ansary (32) S/O- Lt. Yusuf Ansary of Vill-Dumurhir all under PS-Neturia, Dist-Purulia, I, SI Kalyan Kumar Sakha of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 13.05.2021 while I along with C/939 Laltu Paul and NVF/234 Sanjoy Mondal both of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 494 and CC No- 1107/21 dated 13.05.2021 for implementation of Government rules regarding lockdown Disaster Management Plan.
