Sub: Complain to start a specific case.

Sir,

In producing herewith 04 (Four) arrested accused persons namely (1) Joydeb Hansda (31) S/O-Lt. Babulal Hansda of Vill-Bakbari (2) Pabitra Tudu (23) S/O-Ruplal Tudu of Vill-Bakbari (3) Rabindranath Mandi (25) S/O- Sankar Mandi of Vill-Bhurkundabari and (4) Kalimuddin Ansary (32) S/O- Lt. Yusuf Ansary of Vill-Dumurhir all under PS-Neturia, Dist- Purulia, I, SI Kalyan Kumar Sakha of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 13.05.2021 while I along with C/939 Laltu Paul and NVF/234 Sanjoy Mondal both of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 494 and CC No- 1107/21 dated 13.05.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Raibandh Hattola at about 12:55 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Raibandh Hattola but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
