Sir,

In producing herewith 10 (Ten) arrested accused persons namely (1) Sambhu Kumar Chauhan (20) S/O- Raghunath Chauhan of Vill-Parbelia Amdanga (2) Sk. Parbesh Alam (38) S/O- Lt. Hiru Sk. of Vill-Nimdanga (3) Khushi Shaw (32) S/O- Kamalpati Shaw of Vill-Parbelia (4) Md. Irshad (28) S/O- Md. Harul of Vill-Parbelia 8 No. Colony (5) Enod Roy (40) S/O- Sipahi Roy of Vill-Parbelia 3 No. Colony (6) Zioul Hak (50) S/O- Lt. Mohammad Hossain of Vill-Saltore (7) Alope Mandal (49) S/O- Lt. Narayan Chandra Mandal of Vill-Sarbari all under PS-Neturia, Dist-Purulia (8) Saddam Khan (25) S/O- Lt. Hasim Khan of Niyamatpur, Bamandiha (9) Prabhat Kumar Singh (32) S/O- Lt. Brahamdev Singh of Sanctoria Nonia Basti and (10) Madhab Bauri (35) S/O- Lt. Kanthi Bauri of Sanctoria (Malagada) all under PS-Kulti, Dist-Paschim Burdwan, I, SI Sujoy Kundu of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 28.05.2021 while I along with C/78 Utpal Sarkar and C/480 Uttam Bauri both of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 1077 and CC No- 1217/21 dated 28.05.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Parbelia Bazaar at about 17:45 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Parbelia Bazaar but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
