Sir,

*In producing herewith 03 (Three) arrested accused persons namely (1) Md. Tahir (47)* S/O- Md. Jumrati of Vill-Kulti Lalbazar, PS-Kulti, Dist-Paschim Burdwan (2) Koushik Nandi (23) S/O- Ranjit Nandi of Vill-Dhanasdi, PS-Santuri, Dist-Purulia and (3) Khokan Bauri (30) S/O- Tarapada Bauri of Vill-New Colony, PS-Neturia, Dist-Purulia, I, SI Abhijit Das of Neturia PS, Dist-Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 15.05.2021 while I along with C/939 Laltu Paul and NVF/546 Ajit Sing both of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 585 and CC No- 1120/21 dated 15.05.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Parbelia Bazaar at about 18:10 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Parbelia Bazaar but they failed to give any satisfactory answer. So, . they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
