Offence committed u/s:- 148/448/452/506/34 I.P.C.

Complainant respectfully shweth :-

1. That complainant is a permanent resident of village-  
Sarberia, within P.S. Pare, under the jurisdiction of Ld.  
court.

2. That on one day of occurrence at relevant point of time while complt had been repairing for some constructional work in his own land situated in front of his dwelling house all of the accused persons in order to fulfill their oblique intention assembled there with deadly weapons in their hand and gave out threat to the complainant that they will oust the complainant there from by sheer of force even in exchange of life of complainant in which complainant raised protest against such illegal and overt act but accused persons who were very much deterrent to cause harm ~~pushed~~ to his dwelling house . Be it mentioned accused namely Nafil Ansary was armed with Bhojali, Usman Ansary was armed with Lathi, Sahebjan was armed with Tangi. Accused Khodenewaj was armed with an Axe and Rehamgulhad iron rod in his hand . All other accused persons were armed with Lathi.

4. That needless to say accused persons also gave out threat to the other family members to face dire consequence on opportune moment. Such illegal and desparate act of accused persons left a deep trauma to the mental health of the complainant.
5. That several local gentries came to the spot but no one could dare to raise any protest against such illegal act of the accused persons as a result accused persons still moving in the village with their head held high.
6. That complainant reported the incident to local police station at Para against the accused persons on 1.12.2020 but of no result as such complt approached to the Superintendent of Police , Purulia for his remedy through Regd.post on 27.1.21 but no action has been taken against accused persons hence finding no other alternative complainant seeks his relief before Lt.court.

Under such circumstances it is respectfully prayed that necessary direction upon O/C Para police station may be passed to investigate into the matter treating the instant petition as an F.I.R. as per section 156(3) Cr.P.C.
