In producing herewith 09 (Nine) arrested accused persons namely 1) Saddam Gain (21) S/o Sanu Gain of Vill- Sankra - B, 2) Sk. Satikul (19) S/o Sk. Kouth of Vill- Hariharpur,3) Sk. Majafar (22) S/o Gulam Mustafa of Vill- Hariharpur, 4) Shyamapada Roy (32) S/o Sukumar Roy of Vill- Dubra (Fulsuri), 5) Imtaj Khan @ Intaj (33) S/o Manir Khan of Vill- Sankra- B, 6) Toufik Alam (18) S/o Sk. Rafik of Vill- Para, 7) Badal Rana (35) S/o Pagal Rana of Vill- Sidpur, 8) Sastipada Rana (32) S/o Baru Rana of Vill- Sidpur, 9)Md. Saddir S/o Lt- Abdul Gani of Vill- Gurguria, all of PS Para, all of Dist-Purulia. I beg to state that today (28.05.2021), I was directed to find out whether wearing of mask by the public has been properly maintained at Para Bazar area or not. Accordingly, I had been to Para Bazar near Hospital More at about 17.15 hrs and found that a gathering appeared at Para Bazar near Hospital More, none of them were wearing mask. On seeing Police they have tried to escape from the grip of police party but some failed to escape due to efficient effort of Police. On being asked they disclosed their identity as noted above.

In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by government through public servants and through media by strolling, riding without mask instead of follow the COVID rules of wearing mask. They are creating annoyance to the society & violated Govt. order ref. Advisor issued by the Additional Chief Secretary, Govt. of West Bengal vide No- 715 Home (Cons)/RIM (Cons)-92/2021 Dtd- Howrah, the 17th April, 2021 for complete restriction measure. So, I arrested them for Disobedience of order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest i.e.as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. All the process was done in between 17.25 hrs to 18.15 hrs. There was every chance of breach of peace and requiring of offence if not arrested.

Therefore, I pray a specific case may kindly be lodge against 1) Saddam Gain (21) S/o Sanu Gain of Vill-Sankra - B, 2) Sk. Satikul (19) S/o Sk. Kouth of Vill- Hariharpur,3) Sk. Majafar (22) S/o Gulam Mustafa of Vill-Hariharpur, 4) Shyamapada Roy (32) S/o Sukumar Roy of Vill- Dubra (Fulsuri), 5) Imtaj Khan @ Intaj (33) S/o Manir Khan of Vill- Sankra- B, 6) Toufik Alam (18) S/o Sk. Rafik of Vill- Para, 7) Badal Rana (35) S/o Pagal Rana of Vill- Sidpur, 8) Sastipada Rana (32) S/o Baru Rana of Vill- Sidpur, 9)Md. Saddir S/o Lt- Abdul Gani of Vill-Gurguria, all of PS Para, all of Dist-Purulia as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated the rule U/S 188/34 IPC and Section 51(b) National Disaster Management Act- 2005 and arrange for investigation.
