I beg to state that today (28/05/2021) I was engaged in Spl mobile duty at in front of Puncha Kishan Mandi with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 845 Dtd-28/05/2021. Accordingly when I was performing duty at in front of Puncha Kishan Mandi area I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Hence I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (1) order No-79-CS/2020 dated-12.04.2020 (2) Home and hill Affairs Department of the Government of West Bengal vide notification number 347-I.S.S./2M-24/2020 dated-3rd June, 2020 has under Section 2 of the Epidemic Diseases Act, 1897 (3) Advisory issued vide no-715-Home(Cons)/RIM (Cons)-92/2021 dated 17.04.21 (4) Memo No-486-CS/2021 Dated-24th April, 2021 (5) Order no-647-ISS/2M-22/2020, dtd-15/05/2021 of compulsory wearing of mask during this pandemic situation. I issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 17.15 hrs to 18.25 hrs.
