In producing herewith the 11 persons namely (i) Sachin Mahato (19 yrs) S/O Dunu Mahato of Hulka, PS-Purulia (M), Dist-Purulia (ii) Pradip Mahato (25 yrs) S/O Bholanath Mahato of Hulka, PS- Purulia (M), Dist- Purulia (iii) Azaruddin Ansary (23 yrs) S/O Mansur Ansary of Dumdumi. PS-Purulia (M), Dist-Purulia (iv) Ram Akbal Saw (54 yrs) S/O Mallu Saw of Sabji Market, Sindri PS-Sindri, Dist- Dhanbad, Jharkhand State (v) Sunil Kumar Bhuiya (29 yrs) S/O Lt. The fact of the case in a nut shell is that I Chandan Maity along with force namely 1) C/2895 Goutam Betal 2) C/2734 Susanta Panda, 3) C/ 809 Madhusudhan Mahato was performing the Naka duty and Special Mobile Duty being assisted by ASI Nirod Kumar Mahato for the implementation of the order of the State Govt. in the area vide Purulia (M) PS GDE No-151 dtd 5/5/2021 in consonance with C.C No 1028/2021 Dtd. 5/5/2021 as per order of superior. During my Naka and Special Mobile Duty, while I arrived at Imundih more near Pandey Hotel at 14:35 hrs and found 11 (ten) persons noted in the supra were confabulating among themselves sitting beside the road without wearing the mask and maintaining the social distance. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted confabulation beside the road after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021. Subsequently it is pertinent to say that the supra noted persons refused to comply with any direction given by the State Government under The Disaster Management Act, 2005 which is dangerous to life themselves and others. Consequently, the supra noted persons were arrested on the spot and informed them the gourd of their arrest and issued memo of arrest in respect of each persons.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo 486-CS/2021 did 24/04/2021 under The Disaster Management Act, 2005 which is dangerous to life of themselves and others so they can be booked U/S 188/34 of the IPC and read with section 51 (b) of The Disaster Management Act 2005. So a specific case may kindly be initiated against them and arranged for its investigation.
