The fact of the case in a nut shell is that I Chandan Maity along with force namely 1) C/2895 Goutam Betal 2) C/2734 Susanta Panda, 3) C/ 809 Madhusudhan Mahato was performing the Naka duty and Special Mobile Duty being assisted by ASI Nirod Kumar Mahato for the implementation of the order of the State Govt. in the area vide Purulia (M) PS GDE No-151 dtd 5/5/2021 in consonance with C.C No 1028/2021 Dtd. 5/5/2021 as per order of superior. During my Naka and Special Mobile Duty, while I arrived at Imundih more near Pandey Hotel at 14:35 hrs and found 11 (ten) persons noted in the supra were confabulating among themselves sitting beside the road without wearing the mask and maintaining the social distance. accured On being asked they could not give sufficient reason or satisfactory answer of their unwarranted confabulation beside the road after violating the Government order in A 5.5.4 this pandemic situation. Consequently, it reasoned to believe that they violated the at 16:15 km order and disobeyed the direction during this pandemic situation duly promulgated and Startinby Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021. Subsequently Pwrulia wit is pertinent to say that the supra noted persons refused to comply with any direction given by the State Government under The Disaster Management Act. 2005 R Care Mwhich is dangerous to life themselves and others. Consequently, the supra noted persons were arrested on the spot and informed them the gourd of their arrest and 932021 issued memo of arrest in respect of each persons.

As the supra noted persons violated the order and disobeyed the direction US 188/34 during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo of Use 1 pe 486-CS/2021 dtd 24/04/2021 under The Disaster Management Act. 2005 which is be the dangerous to life of themselves and others so they can be booked U/S 188/34 of the IPC and read with section 51 (b) of The Disaster Management Act 2005. So a specific case may kindly be initiated against them and arranged for its investigation.
