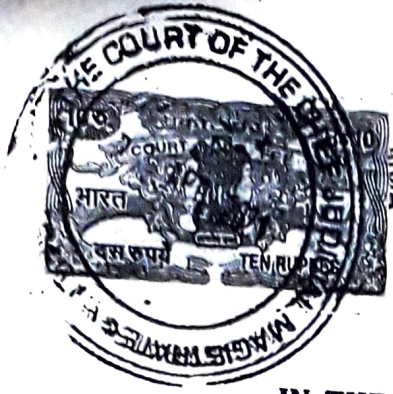

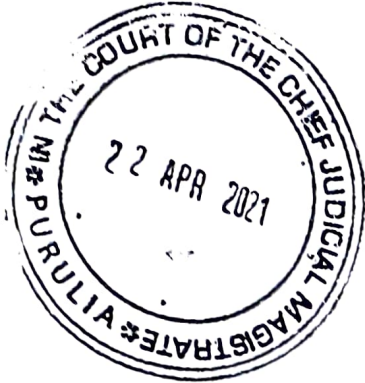

1) That, the R.S.
