
In producing herewith the 05 persons namely (i) Noda Bauri (28 Yrs) S/O Prabhash Bauri (ii) Pintu Bauri (26 Yrs) S/O Pratham Bauri (iii) Dhananjoy Bauri (36 yrs) S/O Late Raghav Bauri (iv) Jiten Mukherjee (33yrs) S/O Satyanarayan Mukherjee (v) Rajesh Bauri (29 yrs) S/O Kuran Bauri all of Vill- Chanchra, PS- Purulia (M), Dist- Purulia before you.

The fact of the case in a nut shell is that I SI Gopika Sundar Dutta along with force namely 1) C/2815 Bibekananda Mahato 2) NVF/811 Banbihari Mahato, was performing the Special Mobile duty for the implementation of Complete Lock Down in the area vide Purulia (M) PS GDE No 449 dtd 16.05.2021 in consonance with C.C No 1109/2021 Dtd. 16.05.2021 as per order of superior. During my Special Mobile Duty, while I arrived at Bhangra more at 14:55 hrs and found 05 (five) persons noted in the supra were confabulating among themselves sitting beside the road without wearing the mask and maintaining the social distance at the complete lock down day. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted confabulation beside the road after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M-22/2020 dtd 15/05/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021. Consequently, the supra noted persons were arrested on the spot and informed them the gourd of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M-22/2020 dtd 15/05/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 so they can be booked U/S 188/34 of the IPC and 3 of the Epidemic Diseases Act. 1897 and read with section 51(b) of the Disaster management Act 2005. So a specific case may kindly be initiated against them and arranged for its investigation.
