Sau and (2) C/3192 Traun Sahoo all of Purulia(T) PS, Dist-Purulia were performing Special Drive against non wearing mask vide Purulia(T) PS GDE No- 1169, Dated- 30.04.2021. During my mobile duty when myself along with force reached at Post Office More on Chaibasa Road at 19:45 hrs and found the above persons were roaming aimlessly at Post Office More without mask. I started to detain them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answers for that movement on road and public place. So, I arrested them, prepared arrest memo and offered medical checkup, but they refused. I also offered them bail, but no sureties turned up. So having no other alternate way I brought the, to PS and put them in lockup maintaining all legal formalities.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & State Govt. has passed order to wear mask in the public place mandatory and ordered to prosecute the defaulters. They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated govt. order. Though in view of Pandemic of COVID-19 outbreak vide Govt. of India order No- 79-CS/2020 dated 12.04.2020 of the Government of West Bengal, Wearing of facial mask has been mandatory in public places in the current pandemic disaster situation. Whereas, vide advisory issued vide no- 715-Home (Cons)/RIM(Cons)-92/2021dated- 17.04.21, Government of West Bengal has stressed that any violation of musk and social distance norms should be strictly dealt with.

Hence I pray before you to start a specific case against the above noted person under proper section of law.
