I, Biman Bihari Chakraborty s/o (L) Durga Mohan Chakraborty, aged at least 72 years, a ret'd. Police officer (MHA) Govt. of India, would like to lodge a complaint against one Tushar Mahato (Mob: 790815994) who in the capacity of a real estate broker tried to sell me a NON-BASTU plot of land owned by Mrs. Kumkum Maitra, by misleading me as it is residential BASTU land (Bhatbandh, RSP lot No. 4558 & 4559, Wilcox Road Bye Lane, Purulia Town).  
Accordingly I, have paid Rs. 2 Lakhs as the booking amount to Mrs. Kumkum Maitra upon the recommendation of Tushar Mahato.

Not only that, Mr. Tushar Mahato took Rs 36,270 which was paid to him by my son over Google pay on transactions made between 11 to 19<sup>th</sup> May, 2021.

Today, i.e. 22/5/2021 when I took the help of a registered Amin to ascertain the actual status of the land, it was revealed that the plot is not a BASTU land and neither the owner. i.e.


Smt. Kumkum Maitra had applied for a conversion nor, did Tushar Mahato inform me about it earlier.

Please Note that we took the expert advice of a Govt Registered Amin Mr. Nirmal Mahato of Pundlic.

When I made arrangements for a meeting between Tushar/Kumkum & the Amin, the former two refrained from attending.

I would like to bring it to your attention that I had been cheated of Rs. 2 lacs & 36,000 by the duo of Tushar Mahato and Kumkum Maitra who deceived & cheated on me, trying to sell a Non Bastu land as Bastu land.
