Sir,

In producing herewith the arrested accused persons namely Arnab Kr. Mishra s/o Anukul Chandra Mishra of vill. Nayanan, PS Chandipur, Dist. Purba Medinipur, Subrata Mukherjee s/o Somenath Mukherjee of vill. Jalaika, PS Purulia (M), Dist. Purulia and Jitu Chandra s/o Bhanu Chandra of vill. Kadamkuli, PS Purulia (T), I beg to state that today i.e., on 25.05.2021 SI Ashis Kumar Chalak (duty officer) received an information from one Basanta Kr. Khedia s/o Lt. Binod Kr. Khedia of Sonu Enclave, Cooks Compound, PS Purulia (T), Dist. Purulia over telephone that a shopping Mall styled as V Mart situated near IDBI Bank, D.B. Road, PS Purulia (T) is selling articles by defying the latest order of partial lockdown issued by Govt. of West Bengal in view of ongoing pandemic situation. Accordingly, duty officer diarised the information vide Purulia (T) PS GDE no. 1036 dtd. 25.05.21 and as per direction of I/C, Purulia (T) PS instructed me to work out the information. As per direction myself alongwith C/599 Sk. Ramjan & HG/1442 Shanti Kundu left PS to work out the information vide Purulia (T) PS GDE no. 1037 dtd.25.05.21.. At about 16:25 hrs I reached at V Mart as noted above and enquired into the allegations. During enquiry it came light that on 25.05:21 at 08:59 AM Manager and cashiers of V Mart namely Arnab Kr. Mishra s/o Anukul Chandra Mishra of vill. Nayanan, PS Chandipur, Dist. Purba Medinipur, Subrata Mukherjee s/o Somenath Mukherjee of vill. Jalaika, PS Purulia (M), Dist. Purulia and Jitu Chandra s/o Bhanu Chandra of vill. Kadamkuli, PS Purulia (T) respectively sold out one T-Shirt (M) VM 54092 & Jeans (M) VM49041 to one Basanta Kr. Khedia s/o Lt. Binod Kr. Khedia of Sonu Enclave, Cooks Compound, PS Purulia (T), Dist. Purulia vide Invoice no.N001502-0521-B71 by defying the latest order of partial lockdown issued by Govt. of West Bengal in view of ongoing pandemic situation vide Order No. 647-ISSS/2M-22/220 dtd. 15/05/2021. The relevant portion of order as noted in Sl. no. 3 is as follows:-

**"Shopping complexes, malls, market complexes, spas, beauty parlors, cinema halls, restaurants, bars, sports complexes, gyms, swimming pools shall remain closed"** and the fourth para of the order says that "Now, after consideration of the


recommendations of the State Executive Committee of West Bengal State Disaster Management Authority and consolidation, expansion and partial modification of aforesaid earlier orders, following directives on the basis of containment approach in terms of provisions under Disaster Management Act 2005 read with West Bengal Epidemic Disease, COVID-19 Regulations 2020, **shall remain in effect from 6 AM of Sunday 16<sup>th</sup> May 2021 to 6 PM of Sunday 30<sup>th</sup> May 2021, in public and collective interest."**

I asked the above noted persons as to why they have violated the latest order of Govt. of West Bengal issued in view of ongoing pandemic situation? But they failed to give any proper account about my query. The above noted activity clearly reflects that the above noted persons intentionally violated the above referred order. On being demand they produced the Invoice vide no.N001502-0521-B71 in respect of the sale of those articles. Accordingly, I seized the said Invoice under proper seizure list in presence of witnesses duly signed by them. I also arrested them as per the procedure laid down in CrPC and followed the latest guidelines of the Apex Court and brought them to PS.

As the above noted arrested accd. persons have violated the Govt. order attracting section 51(1)(b) National Disaster Management Act 2005 and 188/34 IPC, I am submitting suo moto complaint against the above noted accd. persons.

Therefore, I pray before you to start a specific case against the above noted persons under proper section of law and to arrange for its investigation.
