During my mobile duty when myself along with force reached at Post Office More on Chaibasa Road at 18:55 hrs and found the above persons were roaming aimlessly at Post Office More without mask. I started to detain them. On being asked the above noted persons disclosed their identity but they could not able to give any satisfactory answer for their movement on road and public place without wearing mask. So, I arrested them as per the procedure laid down in Cr. P.C and followed the latest guidelines of the Apex Court, prepared arrest memo. I also offered them medical aids, but they refused. I also offered them bail, but no sureties turned up. So having no other alternate way I brought them, to PS and put them in lockup maintaining all legal formalities.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
