Sub: Request for lodging FIR against arrested accused persons.

Sir,

With due respect I beg to submit before you that on 01/05/2021 at about 14:05 hrs. while I, SI Indrajit Sarkar along with C/1474 Tushar Mondal, C/464 Purna Chakraborty and C/638 Lalchand Bag vide CC No. 1097/21 dtd 01.05.2021 were engaged on mobile duty in Raghunathpur Town area and found the following persons were moving at Raghunathpur Bus Stand and moving aimlessly without mask in this pandemic situation and violation of social distancing, as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that moving aimlessly without mask in this pandemic situation and violation of social distancing. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide Memo No. 486-CS/2021 dated- 24.04.2021 and Order No. 79-CS/2020 dated- 12.04.2020. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.
