Sub: Request for lodging FIR against arrested accused persons.

Sir,

With due respect I beg to submit before you that on 11/05/2021 at about 16:15 hrs. while I, PSI Mekdam Sabab along with C/351 Kanailal Bauri, C/1010 Samir Paramanik and C/468 Raju Roy vide CC No. 1183/21 dtd 11.05.2021 were engaged on mobile duty in Raghunathpur Town area and found the following persons were moving at Bhandur More, Raghunathpur and moving aimlessly without mask in this pandemic situation and violation of social distancing, as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that moving aimlessly without mask in this pandemic situation and violation of social distancing. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide Memo No. 486-CS/2021 dated- 24.04.2021 and Order No. 79-CS/2020 dated- 12.04.2020. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

- 1) Kalipada Gorain (35) S/o Lt. Madan Ch. Gorain of Tantipara, Ward No 3, PS – Raghunathpur, Dist.- Purulia.
- 2) Mrinalkanti Mukherjee (54) S/o Lt. Tinkari Mukherjee of Salka near SDO Office, Raghunathpur, PS – Raghunathpur, Dist.- Purulia.
- 3) Haripada Murmu S/o Raichand Murmu of Vill.- Rangamati, PS – Raghunathpur, Dist.- Purulia.
- 4) Samir Nandi (45) S/o Lt. Adhir Nandi of Blockdanga, Ward No 13, PS – Raghunathpur, Dist.- Purulia.
- 5) Tanmoy Mandal S/o Paresh Ch. Mandal of Purbapally, Ward No 1, PS – Raghunathpur, Dist.- Purulia.

Hence it is prayed before you that a specific case may kindly be lodged against the above mentioned persons under proper section of law.
