Sir,

In producing herewith the driver namely Natabar Bauri (21 yrs) S/O - Sasti Bauri of Tiluri, Painsha Kuli , PS-Saltora, Dist-Bankura along with seized vehicle (Tractor) having bearing Registration No.WB55B/2514 having Eng. No-S324F07286 and Chassis No-NHN30320ZKK488102 loaded with sand and attached with Seizure list, Memo of Arrest and Inspection Memo in respect of the supra noted person before you.

The nub of the fact in a nutshell is that on 05.05.2021 at 06:25 hrs while I ASI Ajoy Mukhopadhyay along with force 1) C/557 Ambuj Kumar Mondal, 2) C/99 Shambhunath Dutta both of Santuri PS left the PS for performing mobile duty vide Santuri PS CC No. 1304/2021 and GDE No 152 Dt. 05.05.2021 in PS area. During my mobile duty, I received a tip off at 10:05 hrs that 01 (one) suspicious tractor loaded with sand was proceeding towards Santuri through Hansdima-Poradiha road. Subsequently, I along with force proceeded towards the said road to work out the tip off. While I along with force arrived Hansdima-Poradiha road near Kenduli Mela (Mohanpur village) and found that 01 (one) tractor was proceeding towards Hansdima along Hansdima-Poradiha road. I along with force intercepted 01 vehicle (Tractor) having bearing Registration No.WB55B/2514 having Eng. No- S324F07286 and Chassis No-NHN30320ZKK488102 attached with Trolley is loaded with sand at 10:45 hrs and I found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the vehicle disclosed his name. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the drivers of the tractor loaded the said sand in conspiracy with the owner of vehicle by illegal means for selling the same to make profit by dishonestly and he had been running a clandestine business. So it is reasoned to belief that the accused in conspiracy with the owner of vehicle procured the said sand form Damodar River ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the vehicle (Tractor) having bearing Registration No.WB55B/2514 having Eng. No-S324F07286 and Chassis No-NHN30320ZKK488102 attached with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Natabar Bauri (21 yrs) S/O - Sasti Bauri of Tiluri, Painsha Kuli , PS-Saltora, Dist-Bankura after informing the ground of his arrest and issued Memo of Arrest against him. Thereafter, I brought the seized tractor to Santuri PS compound.

Under the above facts and circumstances kindly take lawful action against the driver namely Natabar Bauri (21 yrs) S/O - Sasti Bauri of Tiluri, Painsha Kuli , PS-Saltora, Dist-Bankura and the owner of the vehicle as they committed offence u/s 379/411/413/414/120B of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957.
