I, SI Subrata Patra S/O Shri Bimal Patra of Vill. Ishabpur, P.S Belda, Dist. Paschim Medinipur do hereby produce (1) Jiban Mukherjee (52) S/O Late Gouri Shankar Mukherjee of Santuri. (2) Dhannanjay Karmakar(42) S/O Narahari Karmakar of Bhagabandh (3) Sanjoy Hari(35) S/O Late Amit Hari of Palaspahari (4) Joydeb Mandi(19) S/O Kanai Mandi of Lapahari (5) Sunil Mondal(62) S/O Late Nakul Mondal of Sadhusaltora(6) Ujjal Modak(50) S/O Late Motor Modak of Madhukunda Bazar (7) Jayanta Kabi(21) S/O Bijoy Kabi of Balitora Upar Bauripara(8) Bipin Maji (32) S/O Ajit Maji of Madhukunda all of P.S Santuri, Dist. Purulia & do hereby lodge a written complaint against them, to the effect that today on 12.05.2021 while I along with C/1154 Jagannath Jha & C/330 Banamali Soren of Santuri PS as per direction engaged in evening mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 450 dtd. 12.05.2021 vide C.C. No. 1396/21 dtd. 12.05.2021) for implementation of Government rules regarding Disaster Management Plan. On 12.05.2021 while we returning from Sadhusaltora side under Santuri P.S jurisdiction and reached at Ledason Morh through Raghunathpur-Saltora Road at about 17:05 hrs. found that the above noted 08(eight) persons were gossiping near Ledasson Morh without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 486-CS/2021 Dated- 24<sup>th</sup> April 2021 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused (1) Jiban Mukherjee (52) S/O Late Gouri Shankar Mukherjee of Santuri, (2) Dhannanjay Karmakar(42) S/O Narahari Karmakar of Bhagabandh (3) Sanjoy Hari(35) S/O Late Amit Hari of Palaspahari (4) Joydeb Mandi(19) S/O Kanai Mandi of Lapahari (5) Sunil Mondal(62) S/O Late Nakul Mondal of Sadhusaltora(6) Ujjal Modak(50) S/O Late Motor Modak of Madhukunda Bazar (7) Jayanta Kabi(21) S/O Bijoy Kabi of Balitora Upar Bauripara(8) Bipin Maji(32) S/O Ajit Maji of Madhukunda all of P.S Santuri, Dist. Purulia under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
