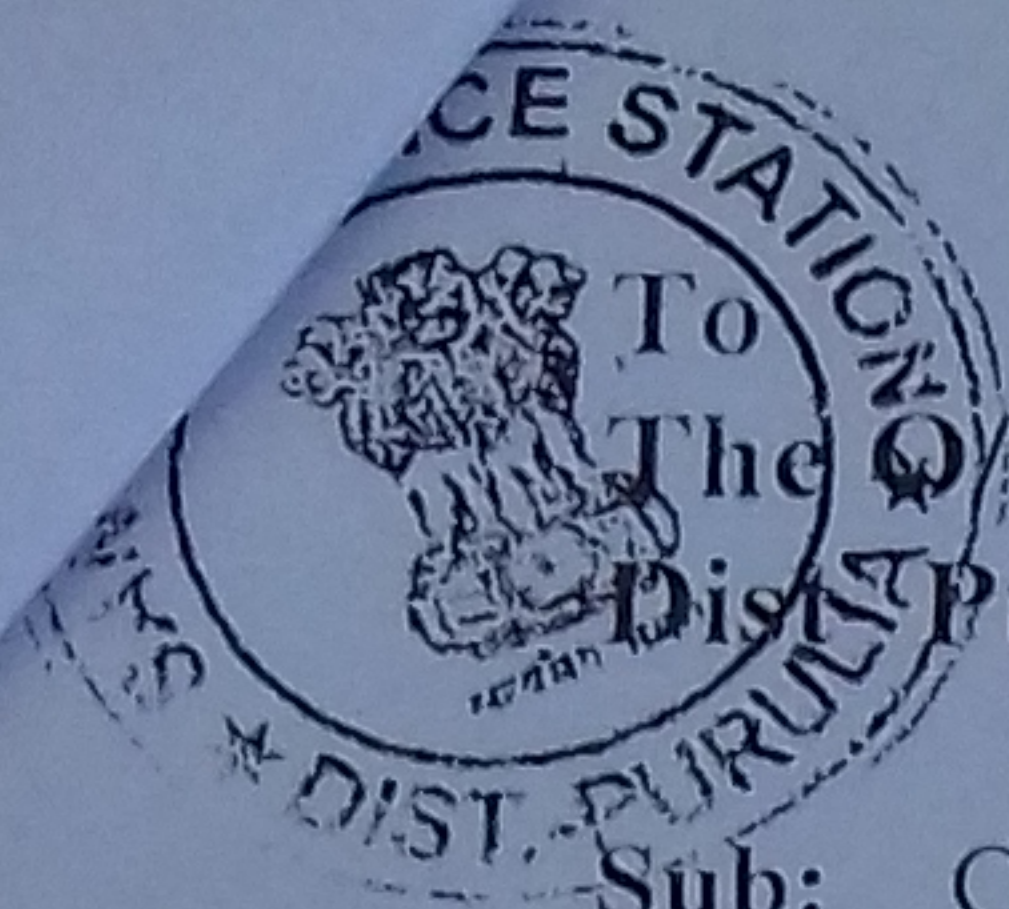

Purulia & do hereby lodge a written complaint against them, to the effect that today on 14.05.2021 while I along with C 330 Banamali Soren & NVF/960 Rajib singh sardar of Santuri PS as per direction engaged in evening mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 532 dtd. 14.05.2021 vide C.C. No. 1421/21 dtd. 14.05.2021) for implementation of Government rules regarding Disaster Management Plan. On 14.05.2021 while we returning from Marbedia side under Santuri P.S jurisdiction and reached at Hansdima Morh through Raghunathpur-Saltora Road at about 16:15 hrs. found that the above noted 07(Seven) persons were gossiping near Hansdima Morh without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in e w (COVID-19). So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 486-CS/2021 Dated- 24th April 2021 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.
