

Sir,

In producing here with two accused persons namely Abul Kasib (19 Yrs), S/O- Sk Islam and Sk Maimuddin (22 Yrs). S/O- Sk Ali Muhammad both are Vill- Kolagara, P.S - Raghunathpur, Dist - Purulia along with following seized articles viz-

- 1) 20 Liters(Approx) of country spirit contained in a white coloured plastic container.
- 2) one motorcycle bearing Reg No -WB 56F 6934 ,

I ASI Manaranjan Singh Sardar of Santuri P.S. do here by lodged a complaint against accd. persons namely Abul Kasib (19 Yrs), S/O- Sk Islam and Sk Maimuddin (22 Yrs), S/O- Sk Ali Muhammad both are Vill- Kolagara, P.S - Raghunathpur, Dist - Purulia to the effect that today (18.05.21) at about 15.35 hrs in course of mobile duty I received a information from a reliable source that two persons are selling illegal country spirit for their personal gain. I informed the matter to O/C Santuri PS and as per direction of O/C Santuri PS, myself along with force rushed to the spot for holding raid by Govt vehicle. At about 15.55 hrs myself along with force reached at open place beside village Bidhakata under Santuri PS , Dist. -Purulia. After held raid and found that one Abul Kasib and Sk Maimuddin were selling the country spirit at open place beside village Bidhakata under Santuri PS , Dist. -Purulia and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accd persons Abul Kasib and Sk Maimuddin, and detained them. I arrested the above mentioned accused persons informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd persons and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Abul Kasib (19 Yrs), S/O- Sk Islam and Sk Maimuddin (22 Yrs), S/O- Sk Ali Muhammad both are Vill- Kolagara, P.S - Raghunathpur, Dist - Purulia and arrange for its investigation.
