The above-named complainant/petitioner begs to state as follows:

- 1. That your petitioner/complainant is resident of village- Kotloi, P.S-Tamna, Dist- Purulia, West Bengal. Witness no.2, witness no 3 and witness no 4 are the relatives of the petitioner/ complainant.
- 2. That on 24/02/2021, at about 8.00 AM, the complainant along with Beli Kumar D/O Ananda Kumar (Daughter of Elder Brother-in-law of the complainant) went to the grocery shop of Ashok Kumar (Accused no 3) to purchase potato at village- Kotloi, P.S- Tamna, Dist- Purulia, W.B, during that time wife of Ashok Kumar i.e Debjani Kumar (Accused no.6) was sitting at the grocery shop and she uttered slang dialect mentioning Beli Kumar as 'Sali Banji' 'Bhatar Chari' and used filthy unparliamentary words and abused her. On witnessing so the complainant and Beli Kumar protested against such abuse and there was verbal altercation between them and the two were driven out from the said grocery shop by Debjani Kumar W/O Ashok Kumar. After being driven out from the shop the complainant and Beli Kumar returned to their home.
- 3. That on 26/02/2021 the complainant and their family members got informed that Accused no 3 had lodged a false complain regarding the above-mentioned incident on hearing so Peri Kumar S/O Late Ashini Kumar (Brother-in-law of complainant) and Sasanka Kumar S/O Ananda Kumar (Son of brother-in-law of the complainant) at about 7.00 AM to 7.30 AM went to the grocery shop of Ashok Kumar and told him that, 'because of some altercation between the females you have lodged a false case against them'.
- 4. That on hearing such conversation Accused no-1 to Accused no 8 all became furious and vindictive and suddenly rushed inside their house and they all brought sharp deadly weapons i.e 'Farsha' and Iron road and the female accuseds were armed with 'Bothi' (Sharp cutting instrument) and they surrounded Peri Kumar and Sasanka Kumar from all sides. Accused no 2 assulted Sasanka Kumar with Farsha over his head with an intention to murder him and on receiving such deadly blow Sasanka Kumar fell on the ground.
- 5. That on hearing such hue and cry Chaitu Kumar, Budhu Kumar and Subhash Kumar all S/O Peri Kumar, Thasak Kumar S/O Late Ashini Kumar

and the complainant rushed to the spot and witnessed that Sasanka Kumar was lying on the ground with bleeding injury over his head and all the accused persons were biting him with kicks. Ashok Kumar (Accused no 3) was assaulting Peri Kumar on his leg by the wooden side of 'Farsha' and when Peri Kumar was trying to free himself from the deadly blows, Subhash Kumar (Accused no 8) grabbed Peri Kumar from behind and Tarun Kumar (Accused No 1) rushed inside the house and brought a pistol and fired at Peri Kumar with intention to take his life but fortunately the bullet missed him and Accused no 8 got injured from such bullet wound on his right hand.

- 6. That thereafter the complainant and the family members took Sasanka Kumar and Peri Kumar to Tamna P.S to lodged complain but police refused to lodged their complain.
- 7. That on the same night the accused persons again came to the house of the complainant and they vandalised the house of the petitioner broken the roof tali and the main door of her residence and threatened that if any family member of the complainant is seen in the village, they will be shot dead. In fear of life the complainant and her family members were forced to leave their village because of such death threat.
- 8. That your petitioner has informed about the ordeal faced by her and her family members to the local police station at Tamna P.S. by registered post, but the police did not take any complain neither started any specific case against the above named accused persons.
- 9. That finding no other alternatives your petitioner has knocked the door of Superintendent of Police, Purulia on 06/04/2021 but nothing has been done from his end.
- 10. That your petitioner is a helpless woman having full faith in the justice delivery system of the country and for all these it is desirable and prayed that this case should be converted to a police case.

It is respectfully prayed that under such Circumstances and for the reasons stated
