In producing here with one arrested accused namely Romeo Das Modak (31 Yrs) S/O Ranjit Das Modak of Vill- Gayadih, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 14 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-50 of each bottle.

I SI Madan Chandra Supakar of Adra PS do here by lodged a complaint against accused namely Romeo Das Modak (31 Yrs) S/O Ranjit Das Modak of Vill- Gayadih, PS-Adra, Dist- Purulia to the effect that on 22/06/21 at about 16:25 hrs I received a information from a reliable source that one Romeo Das Modak has been stock of country spirit illegally at his Jhupri at Gayadih. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS GDE No-813 dtd.22.06.21. I reached at Gayadih Adra at about 16:35 hrs and hold raid in the Jhupri of said Romeo Das Modak and found that the said person selling liquor at his Jhupri and after seeing the Police party some person fled away and said Romeo Das Modak has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Romeo Das Modak selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Romeo Das Modak (31 Yrs) S/O Ranjit Das Modak of Vill-Gayadih, PS-Adra, Dist-Purulia under proper section of law.
