at Dureshini Pahar area under P/S Bardwan Purulia.

During movement of force (ASI-01
and 16 constables) towards Dureshini by the vehicle 407
no. W.B-55-3749 through Begunkodon-Arsha road, the
driver of said vehicle fail to control on the vehicle,
W.B-55-3749 due to drive in high speed. As a result
of it the vehicle went down to the road side field
around 10 ft low from the road at a turning near
Kumardi u P/S Arsha, Purulia. The said have taken place at
15:30 hrs on 04/06/2021

Two constables, viz, C1863 Amannath
Pradhon & C1541 Somatom Majhi injured seriously both
of them have shifted to Durgapuri Mission Hospital after
first aid and other 11 constables have released from Purulia
Deben Mahato Hospital after necessary treatment, not only
this due to the said accident three Insas Arms dam became
damage fully, another 2 pcs AKM, 08 pcs SLR, 02 pcs Insas
damage partially.

Therefore I request to investigate
the incident and take necessary actions against the driver
of vehicle no. 470 no W.B-55-3749.
