Subject:- An application to note a complaint/ F.I.R and take necessary actions.

Sir,

With due respect I, the undersigned would like to state that my marriage took place with Surjasikha Singh Sardar (Mura) in the year 2017 at her father's resident at Vill- Tumrasole, P.S- Barabazar, Dist- Purulia(W.B) as per the Hindu Rites and Customs prevailing in our Society. After our marriage we started residing together as husband and wife at my resident at Vill- Ajodha, P.S- Bagmundi, Dist- Purulia (W.B) my wife Surjasikha Singh Sardar (Mura) stayed with me very happily for two months and after two months her father and mother namely took her to their house I allowed happily. Then she returned after 7 days. Staying together at my house for few days again she asked to go to her father's house I said her to wait for few days as I was very busy in my work during those days. Within 2 days her relatives namely (1) Fulki Singh Sardar (her didi), (2) Bharati Singh Sardar (her kakima) came to my house and created pandemonium stating that I am not allowing my wife to go to her parental home, I requested them that after few days I shall escort my wife there but they did not hear and kept on shouting and demanding. I out of my innocence allowed my wife to go with them. After two three days while searching my almirah I could recognised that my wife took all her articles, the silver and golden ornaments which I gave her after marriage, which she got at the time of our marriage as gifts and some amount of cash from my almirah in my absence or without letting me know. I just asked her about the missing things she accepted that she took all of them but I didn't utter a single word regarding the same thinking about the future of our relationship.

But few days later, her behaviour totally changed, she started avoiding me, I on repeated occasions went there to bring her back to my house but her relatives did not allowed her to come along with me and gave lame excuses about her studies, examinations and others. My wife confessed before me that her family members are not letting her to come with me as they have some ill intentions.

Then too I did not gave up on repeated occasions I visited my father in laws house but for reasons unknown, there I had received very bitter behaviour from their side.

Then I stopped visiting their house but I almost once or twice in two three months visit at that Village, to the house of my relatives and friends from where I came to know about my wife and others.

I think my wife is actually innocent she wants to reside with me as husband and wife but her relatives and family members are not letting her live with me , they have created mental pressure on her such that she do not show any willingness to reside with me.

I went to meet my wife at my father in laws house but the culprits did not allow me to meet her rather they used slang language to me, threw me out from their house and threatened me if i visit there again then they shall kill me.

She is my married wife, how can they give marriage of her when i am alive, when no Divorce has been taken place in between us. It's totally illegal. In recent past I came to know that on 09.05.2021 the culprits forcefully settled marriage of my wife Surjasikha Singh Sardar (Mura) with Bhuti Singh (Munda) of Vill- Gutiuḷi, PO- Bansa, PS- Chowka, Rajkorsona, Jharkhand without my consent .

And if my wife has given her consent she must be given it out of force or undue influence, she should be saved from their clutches and recovered from the illegal nexus. In this situation I am feeling helpless hence is submitting this application before Your Office for investigating into the matter and taking necessary action against them such that they may be prosecuted as per Law.
