Sub. - Prayer for starting a specific case U/S- 46 A (c) B.E. Act 1909 against Bhupesh Chandra Saw (32 Yrs), S/O-Krishnapada Saw of Vill-Kuchi, PS-Baghmundi, Dist- Purulia.

Sir,

In producing herewith the accused person namely Bhupesh Chandra Saw (32 Yrs), S/O-Krishnapada Saw of Vill-Kuchi, PS-Baghmundi, Dist-Purulia along with seized articles 1. 15 ltr ID liquor in a plastic jericin which was seized under proper seizure list duly signed by the witness.

I beg to submit that today on 02.06.2021 during mobile duty as per source information I SI Snehasish Mondal and ASI Dinsh Rajak along with force 1. C/610 Achinat Bauri, 2. C/2062 Manajit Bairagi both of Baghmundi P.S, Dist-Purulia reached at Kuchi Village at 17:25 hrs and found that the above noted person is selling ID Liquor at Kuchi Village in his shop under Baghmundi P.S, Dist Purulia. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of ID Liquor. As such he was arrested at 18:05 hrs U/S- 67 B.E. Act maintaining all formalities and guidelines regarding arrest. I also seized from his possession 1. 15 ltr ID liquor in a plastic jericin which is seized U/S- 67 B.E. Act under proper seizure list duly signed by the witness. All seized articles were labeled properly in presences of witness and accused person. I offered him medical treatment but he denied.

The above noted arrested accused person namely Bhupesh Chandra Saw (32 Yrs), S/O-Krishnapada Saw of Vill-Kuchi, PS-Baghmundi, Dist- Purulia committed an offence U/S- 46 A (c) B.E. Act 1909 for unauthorized possession and selling ID liquor from his sole possession.

. Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and arrange its investigation.
