In producing herewith 1. Rahul Sing Mura (25 Yrs), S/O-Madan Sing Mura of Vill-Chatua, 2.Sukdeb Kumar (35 Yrs), S/O-Lt-Dhrubalal Kumar of Vill-Sarjumatu, 3.Ranjit Paul (33 Yrs), S/O-Lalmohan Paul of Vill-Gagi, 4.Karna Kuiry (25 Yrs), S/O-Beni Madhab Kuiry of Vill-Noyadih, 5.Jagannath Kuiri (32 Yrs), S/O-Nilkanta Kuiri of Vill-Noyadih, 6.Jagjiban Sing Babu (35 Yrs), S/O-Lt-Ramkista Sing Babu of Vill-Simali, 7.Jiten Poddar (30 Yrs), S/O-Lt-Jiban Poddar of Vill-Gagi and all are of PS-Baghmundi Dist-Purulia to the effect that on 22.06.2021 while I SI Snehasish Mondal along with force 1) C/53 Debendranath Majhi and 2) C/900 Saikat Sarkar both of SAP 11th Bn. camp at Baghmundi PS, Dist-Purulia were performing mobile duty vide Baghmundi PS GDE No- 889, Dated- 22.06.2021. During my mobile duty when myself along with force reached at Kalimati More on Baghmundi-Jhalda Main Road at 18:25 hrs and found above persons were roaming aimlessly at Kalimati More Area without mask or its alternative. I detained them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the State Govt. has passed order to wear mask in the public places mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt. is Memo No-486-CS/2021, Dtd: 24.04.2021.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request. So I arrested them for violating the section of Disaster Management Act 2005.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
