Bhutunath Mahato of Vill-Khatam, PS-Barikul, Dist-Bankura (6) Kailash Mahato (36Y) S/O-Lt. Gopal Mahato of Vill-Jiling, PS-Barabazar, Dist-Purulia, I SI Jol Kumar Mandy of Bandwan PS, beg to state that as per your kind order vide Bandwan PS GDE No-484, Date-12/06/2021 & C.C No-1368/21, Date-12/06/2021, today i.e. on 12.06.2021 at about 14:35 hrs while myself along with force were performing Spl. drive against non wearing mask in such pandemic situation at Bandwan Chwak Bazar then on 12/06/21 in between 14:55 hrs to 17:45 hrs I found the above noted 06 (six) persons were roaming aimlessly by non using mask at that place. In course of my duty with the help of accompanied (1) C/1111 Ragda Mandi (2) C/152 Paresh Nath Bauri both of Bandwan PS, Dist-Purulia, I intercepted them at Bandwan Chawk Bazar under Bandwan PS. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to speed of Corona virus (Covid-19). Corona virus is going on throughout the District of Purulia. In this situation they were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic and violated the protocol and restriction to curb down the pandemic situation reference order No. 647-ISS/2M-22/2020, dtd-15/05/2021. In view of Pandemic of COIVD-19 outbreak the above noted persons were arrested after maintaining all formalities regarding arrest rules and prepared arrest memos brought them to P.S.

So, I pray that a specific case U/S-188/34 IPC & read with section 51 of Disaster Management Act, 2005 may kindly be started against above noted accused persons and to arrange for its investigation.
