Sir.

In producing herewith arrested two persons namely (1) Shankar Kar (53) S/O- Lt. Biswanath Kar Vill- Ankro (2) Pintu Mahato (25) S/O- Parikshit Mahato of Vill- Pratapur both of PS- Boro Dist- Purulia with seized article (1) One white colour Pickup Van having Chassis No. MA1ZN 2TBKK1864928 and engine No. TB K1H 71638, Regd. No. WB55B/ 1649, with loaded 30 packets wheat (contain approx 40 Kg for each bag) (2) Mustard seed 02 packets approx 75Kg (3) Mahua flower 25 Jute bags containing 40Kg for each bag and approx 1000 Kg in total. I beg to submit that on 21.06.2021 while I, SI Anirudhya Chatterjee along with C/11 Asim Roy (2), C/358 Ganesh Roy vide CC No. 1036 dated- 21.06.2021 and GDE No. 675 dated- 21.06.2021 all are of Boro PS were performing evening mobile duty in this period at about 19.45 hrs received a secret information from a credible source that a white colour Pickup Van having Regd. No. WB55B/ 1649 is coming from Kutni side towards Raghunathpur in suspicious manners. Accordingly myself with force reached at Raghunathpur and found that said Pickup Van loaded with article were proceeding towards Raghunathpur from Kutni side in a suspicious manner and after a hot chase, we could succeeded to intercept the said Pickup Van having Regd. No. WB55B/ 1649 with its driver namely Pintu Mahato S/O- Parikshit Mahato of Vill- Pratapur and one Shankar Kar S/O- Lt. Biswanath Kar Vill- Ankro both of PS- Boro Dist- Purulia. On interrogation, they stated that the vehicle is loaded with wheat, mustard seed and Mahua flower. Accordingly we asked to produce relevant documents about the articles but they failed to produce any valid documents in support of ownership of loaded containing articles.

On enquiry, it is reason to believe that the aforesaid alleged persons have been running a clandestine business over essential commodities and illegal excise goods for illegal means for wrongful gain after hatching up a criminal conspiracy by means theft or buy sell and transportation of the articles.
