In producing here with 01(One) arrested accused person namely Rajkumar Singha (19) S/O Nitu Singha of Vill- Raja Hensla, PS-Jhalda, Dist-Purulia and brought under seizure 01 (One) Tractor without number plate having engine no RJK2EAN0037 and chassis no MBNABAEXPJRK03912 attached with a sand loaded trolley. The fact in brief is that today (01.06.2021) at about 10:15 hrs. received a credible source information that one Tractor was carrying sand illegally and coming from Tribeni Ghat which is situated on Subarnarekha river at Jharkhand Purulia Border & going towards Baghmundi side. Accordingly, myself along with force left PS to work out the said source information. This refers to Jhalda PS GDE No- 36 Dated- 01/06/2021 & Jhalda PS CC No- 1472/21 Dated- 01/06/2021. Then, we started Naka Checking at Jargo more on Jhalda Baghmundi road and intercept the said Tractor at Naka checking point at about 10:45 hrs and found the above noted tractor was tagged with a trolley loaded with sand. On asked, the driver disclosed his identity as mentioned earlier. On demand, he failed to produce any valid papers in respect of the Tractor and attached Trolley as well as loaded sand though sufficient time was given. During interrogation, the driver of the said tractor confessed that he in convince with the owner of said seized Tractor & others is doing this illegal business of sand and he has no proper paper or royalty challan. Then, I SI- Bimal Kr. Tudu arrested accused driver of said vehicles (as disclosed during interrogation)- (i) Rajkumar Singha (19) S/O Nitu Singha of Vill- Raja Hensla, PS-Jhalda, Dist-Purulia, and seized Tractor without number plate having engine no RJK2EAN0037 and chassis no MBNABAEXPJRK03912 with attached sand loaded Trolley(approx 100 cft) with proper seizure list.

It is also fact that though National Directive for COVID-19 Management (Unlock-2) is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide order No- 79-CS/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 846-CS/2021 dtd. 24.04.2021 for restriction measure. And lockdown is also going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of West Bengal consolidated order No- 647-ISS/2M-22/2020 dated-15/05/2021 and Memo No-713-ISS/2M-22/2020 dated-31/05/2021 for complete restriction measure. Therefore, there is restriction of movement except emergency purpose. But during interrogation with the driver it is known that he has no come out for any emergency purpose. So he disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule.

On return to P.S., Put the arrested accused person into the P.S. Lock UP after maintaining all formalities, kept the sand loaded seized Tractor at PS compound and I do here by submitting written complaint before you to start a cognizance against (i) Rajkumar Singha (19) S/O Nitu Singha of Vill- Raja Hensla, PS-Jhalda, Dist-Purulia (ii) Owner of the Tractor without number plate having engine no RJK2EAN0037 and chassis no MBNABAEXPJRK03912 & others under proper section of law.
