Moreover, it has also been in the notice of the Undersigned that he has misbehaved with the visitors who come at the Park on several occasions and not only that, he has also tried to extort money from them forcefully.

As such, it is evident that he is an anti social element who has been creating a fearful environment around the public place and the Undersigned assumes that he may cause further inconvenience to visitors/public thereat, if strict action is not taken against the miscreant for his illegal activities.

You are therefore requested to kindly lodge a F.I.R. against him as well as to take needful action against him to maintain law and order in the area.
