Sir,

In producing here with one arrested accused person namely Dilip Mahato S/O Lt. Nanu Mahato of Vill- Hesalbera, PO-Durgl, PS-Kotshila, Dist- Purulia and brought under seizure (i) One Maruti Suzuki EECO having Reg. No- JH 09AW 5904 (ii) 582 (Five hundred eighty two) Pieces sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup, WELCYREX Cough Syrup @ 132 Rs./bottle, having 100 ml in each bottle contained in 05 cartons.

I do here by lodged a written complaint against the above noted accused person and others to the effect that on 10/06/21 at 19:05 hrs while performing Anti Crime evening mobile duty myself ASI- Sk. Abdul Jamshed along with force (C/497 Ambuj Kr. Mandal, H.G/1681- Manamatha Kumar and H.G/1807 Shyam Sing Laya) with Govt. vehicle, vide CC No-1564/21, Dtd. 10/06/21, started Anti Crime Naka checking at Baragram Bagan on Ranchi Purulia Road. At 20:15 hrs. we detained one vehicle, Maruti Suzuki EECO having Reg. No- JH 09AW 5904. There were 4/5 persons inside the said vehicle. Seeing police party all started to flee away but we managed to apprehend 01 (one) person who was in driver seat. On suspicious ground we checked and searched the vehicle and found huge amount of illegal cough syrup inside the vehicle. After searching we found there was 05 cartons containing 582 (Five hundred eighty two) Pieces sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup, WELCYREX Cough Syrup @ 132 Rs./bottle, having 100 ml in each bottle. On demand he failed to produce any valid documents/ license in respect of keeping and carrying the said illegal drugs. On being asked he disclosed his identity as noted above and admitted that he along with (i) Santosh Bhakat of Ichag, (ii) Sanjay Karmakar of Jhalda, (iii) owner of the said vehicle and others are dealing in this illegal business of prohibited cough syrup. He also admitted that they brought these cough syrups from Chas, Bokaro area and will sell to local people to the Jharkhand and Kotshila.

So I seized the same from his possession and involved vehicle having Reg. No- JH 09AW 5904 under proper seizure list duly signed by the Police witnesses as there was no other local witness available right that moment and as well signed by the apprehended person and also prepared label with seal one bottle of "Chlorpheniramine Maleate & Codeine Phosphate Syrup, WELCYREX Cough Syrup" as sample. I arrested the above noted accused person for violating the sec. 27 of drugs & cosmetics Act 1940 after maintaining all formalities and also inform him the ground of arrest.

I therefore pray before you to start a case against the accused persons namely (i) Dilip Mahato S/O Lt. Nanu Mahato of Vill- Hesalbera, PO-Durgl, PS-Kotshila, Dist- Purulia, (ii) Santosh Bhakat of Ichag, (iii) Sanjay Karmakar of Jhalda, (iv) owner of the said vehicle and others as per law and arranged for its investigation.
