NAKA checking duty at Jhaldia (Brida more) under Jhaldia PS. During Spl. NAKA checking duty as per direction we were engaged for implementation of Govt. rules regarding disease management plan. During Spl. NAKA checking duty at 18:05 hrs. at Jhaldia (Brida more) under Jhaldia PS, Dist- Purulia and checked and detained above noted accd. persons as they did not wear mask on their face and moving casually without maintaining social distance. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. So, there is every reason to believe that the accd. persons came out from their home without wearing mask and maintaining social distance and moving aimlessly or making fun and they did not come for emergency purpose. Though National Directorate for COVID-19 Management (Unlock-3) is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide order No- 79-C5/2020 dtd. 22.04.2020 of the Government of West Bengal and Memo No- B46/C5/2021 dtd. 24.04.2021 for restriction measure. And lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of West Bengal consolidated order No-647-SS/20-22/2020 dated-15/05/2021 for complete restriction measure. As such the above persons violated the order vide order No- 79-13/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 646-C5/2021 dtd. 24.04.2021 for restriction measure. And order No- No-647-SS/20-22/2020 dated-15/05/2021 And order No- 753-SS/20-22/2020 dtd-14/06/2021 which is extended till 30.06.2021. Therefore they disobeyed Govt. order and committed neglect act likely to spread infection of disease dangerous to life and violated Quarantine rule. I arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodge against above noted 22 (Twenty Two) accd. persons as they disobey Govt. order and committed neglect act likely to spread infection of disease dangerous to life and violated Quarantine rule U/S 148 IPC and 51 (1)(b) of Disaster Management Act, 2005 and arrange for investigation.
