Sir,

In producing here with 01(One) arrested accused person namely Abani Mahato (38) S/O Fulchand Mahato of Vill- Guridih, PO-Mahatomara, PS- Jhalda, Dist- Purulia and along with 02(two) seized Tractors- (i) WB55A 4426 (ii) WB55B 2920 both are attached with sand loaded trolleys. The fact in brief is that today (20.06.2021) during my Mobile duty at Jhalda Bus stand vide Jhalda P.S. GDE No- 735 Dated- 20/06/2021 & Jhalda PS CC No- 1651/21 Dated- 20/06/2021 at about 18:25 hrs. received a credible source information that few Tractors were carrying sand illegally and coming from Guridih Ghat which is situated on Subarnarekha river at Jharkhand Purulia Border & going towards Mahatomara side. To work out this information we went to Mahatomara more (On Jhalda Gola road) and started Naka Checking. We intercept the said Tractors at Naka checking point at about 19:25 hrs and found the above noted tractors were tagged with trolley loaded with sand. When I stopped the vehicles seeing the Police party, drivers and others persons who were on that vehicles (Tractors) started to flee away. After hot chase we managed to apprehend 01 (one) driver namely Abani Mahato (38) S/O Fulchand Mahato of Vill- Guridih, PO-Mahatomara, PS- Jhalda, Dist- Purulia, who was driving tractor bearing registration no-WB55A 4426. But driver of the rest tractor and others fled away. On asked, the driver disclosed his identity as mentioned earlier. On demand, he failed to produce any valid papers in respect of the Tractor which is attached with Trolley as well as loaded sand though sufficient time was given. During interrogation, the driver of the said tractor confessed that he in convince with the owner of said seized Tractors & others is doing this illegal business of sand. They do not have any challan/papers in respect of loded sand. So, I ASI Sk Abdul Jamshed following arrested accused driver (as disclosed during interrogation)- (i) Abani Mahato (38) S/O Fulchand Mahato of Vill- Guridih, PO-Mahatomara, PS- Jhalda, Dist- Purulia (driver of the tractor WB55A 4426) under proper arrest memo and also seized the Tractors- (i) WB55A 4426 (ii) WB55B 2920 with attached sand loaded Trolleys (approx 100 cft) in each Tractors.

It is also fact that though National Directive for COVID-19 Management (Unlock-2) is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide order No- 79-CS/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 846-CS/2021 dtd. 24.04.2021 for restriction measure. And lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of West Bengal consolidated order No-647-ISS/2M-22/2020 dated-15/05/2021 for complete restriction measure. As such the above persons violated the order vide order No- 79-CS/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 846-CS/2021 dtd. 24.04.2021 for restriction measure. And order No- No-647-ISS/2M-22/2020 dated-15/05/2021 And order No-753-ISS/2M-22/2020 dated-14/06/2021 which is extended till 30.06.2020 for complete restriction measure. Therefore, there is restriction of movement except emergency purpose. But during interrogation with the driver it is known that he has no come out for any emergency purpose. So he disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule.

On return to P.S., Put the arrested accused person into the P.S. Lock UP after maintaining all formalities, kept the sand loaded seized Tractors at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Abani Mahato (38) S/O Fulchand Mahato of Vill- Guridih, PO-Mahatomara, PS- Jhalda, Dist- Purulia (ii) Owner of the Tractor having registration no WB55A 4426 (iii) Driver of the Tractor having registration no WB55B 2920 (iv) Owner of the Tractor having registration no WB55B 2920 & others under proper section of law.
