The fact of the case in a nut shell is that I SI Sk Ismail Ali along with force namely (i) C/1496 Subal Ch Mahato (ii) HG/1772 Fatik Ch Kumar & (iii) NVP/778- Samir Kumar Mahato was performing the Special Mobile duty for the implementation of the Govt Order in the area vide Jhaldai PS GDE No 887 dtd.24.06.2021 in consonance with C.C No 1692/21 Dtd. 24.06.2021 as per order of superior. During my Special Mobile Duty, while I arrived at Jhaldai Bus Stand at 11:40 hrs. and found 07 (seven) persons noted in the supra (SI no 1-7) were confabulating among themselves sitting beside the road without wearing the mask and maintaining the social distance at the partial lock down in all over the state and remaining persons noted in SI no (8-24) were loitering near bus stand without wearing mask. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted confabulation beside the road after violating the Government order in this pandemic situation and loitering aimlessly without wearing mask. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M-22/2020 dtd 15/05/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-707-ISS/2M-22/20 dtd. 29.05.21. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M-22/2020 dtd 15/05/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-707-ISS/2M-22/20 dtd. 29.05.21 so they can be booked U/S 188 of the IPC and 51 (1) (b) of the Disaster Management Act 2005 and read with section 3 of the Epidemic Diseases Act, 1897. Ergo a specific case may kindly be initiated against them and arranged for its investigation.
