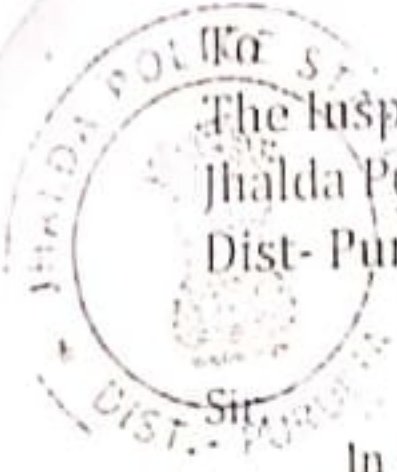

In producing here with one arrested accused person namely Indra @ Githni Sardar (45 Yrs) W/O-Jagabandhu Mahato, D/O Akla Sardar of Vill-Kansra, PS-Jhalda, Dist-Purulia under proper seizure of (i) 163 (One hundred sixty three) sealed bottles of "REXUS" cough syrup of 100 ml each @ 120 (ii) 82 (Eighty two) sealed bottles of "CODCOF-NF" Cough Syrup of 100 ml each @ 120, after preparing proper seizure list duly sign by the witnesses.

I, SI, Milon Manna of Jhalda PS do here by lodged a written complain against Indra @ Githni Sardar (45 Yrs) W/O-Jagabandhu Mahato, D/O Akla Sardar of Vill-Kansra, PS-Jhalda, Dist-Purulia to the effect that today (24/06/2021) at 15:45 hrs. after receiving a source information that a huge quantity of cough syrup are stored in the house of Indra @ @ Githni Sardar at Kansra village under Jhalda P.S. I communicated the matter to I/C Jhalda P.S. over telephone and as per order of I/C, myself along with ASI- Abdul Jamshed, C/1496- Subal Ch. Mahato, C/497- Ambuj Kr. Mandal, L.C/3049- Parul Mahato, L.C/977- Gita Majhi of Jhalda P.S. left P.S. to work out the information (This refers to Jhalda P.S. GDE No- 902 Dt- 24/06/2021, vide C.C. No- 1694 Dt- 24/06/2021). We reached at Kansra village at 16:25 hrs. and parked the Govt. vehicle in a safe distance and conducted raid at the house of Indra @ Githni Sardar (45 Years) W/O-Jagabandhu Mahato, D/O Akla Sardar of Vill-Kansra, PS-Jhalda, Dist-Purulia. Myself along with force searched the house thoroughly and found a huge quantity of cough syrup inside her house. I asked her to produce any valid license in respect of keeping said illegal drugs. But she failed to produce any valid documents in respect of said drugs. So, I seized (i) 163 (One hundred sixty three) sealed bottles of "REXUS" cough syrup of 100 ml each @ 120 (ii) 82 (Eighty two) sealed bottles of "CODCOF-NF" Cough Syrup of 100 ml each @ 120, from the possession of Indra @ Githni Sardar in between 16:45 hrs. to 17:05 hrs. after preparing proper seizure list duly sign by Police witnesses due to unavailability of Public witnesses and label it. I interrogate said Indra @ Githni Sardar in presence of lady constables. On interrogation, she confessed her guilt and admit that she gather the illegal cough syrup for the purpose of sale. So, at 17:15 hrs., I arrested Indra @ Githni Sardar (45 Years) W/O-Jagabandhu Mahato, D/O Akla Sardar of Vill-Kansra, PS-Jhalda, Dist-Purulia for violation of Sec-27 of Drugs & Cosmetics Act-1940 with help of Lady constables and after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a specific case against accused person named Indra @ Githni Sardar (45 Years) W/O-Jagabandhu Mahato, D/O Akla Sardar of Vill-Kansra, PS-Jhalda, Dist-Purulia as per law and arrange for its investigation.
