Sub: Prayer for lodging F.I.R. against arrested accused persons namely Nilkamal Mahato (28 Yrs) S/o- Sudhir Mahato of Vill- Panrhrama, PS- Tamna Dist- Purulia & 08 others.

Sir,

With due respect I SI Abhijit Singha of Joypur PS, beg to submit before you that on 28/06/2021 at about 08:15 hrs while myself along with force were performing Special Mobile-I duty at PS area and conducting raid against non-wearing of mask physical distancing maintaining at Atakol More under Joypur Bazar on Purulia-Ranchi road as per order of my superior vide Govt. Memo No. 715-Home (Com)/RIM/ (Com)-92/21 dated 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distance norms should be strictly dealt with and Order No-753-ISS/2M-22/2020 Date-14/06/2021, Order No-713-ISS/2M-22/2020 Date-31/05/2021, Order No-647-ISS/2M-22/2020 Date-15/05/2021 & Memo No-629-ISS/2M-22/2020 dated 05-05-2021, Memo No-618-ISS/2M/2020 dated 30-04-2021 & Memo No-622-ISS/2M-22/2020 dated 01/05/2021 Date-28/06/2021 & CC No-2445/21 Date-28/06/2021 and found the following persons, were roaming at Atakol More under Joypur Bazar on Purulia-Ranchi road SH-4A without any face cover / mask & were gather in a place without maintaining physical distancing. In spite of several request & reminder they refuse to wear mask and roaming at public place. To prevent the spread Covid-19 pandemic situation. I asked them to wear mask but they did not comply my request & roaming in the Joypur Bazar without face cover / mask. Myself along with accompanied force detained them at Atakol More they were coming from other villages. On being asked the following persons could not able to give any satisfactory answer for their presence at public place without face cover / mask. In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by Government order vide Memo No. 715-Home (Com)/RIM/ (Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distancing norms should be strictly dealt with and Order No-753-ISS/2M-22/2020 Date-14/06/2021, Order No-713-ISS/2M-22/2020 Date-31/05/2021, Order No-647-ISS/2M-22/2020 Date-15/05/2021 & Memo No-629-ISS/2M-22/2020 dated 05-05-2021, Memo No-618-ISS/2M/2020 dated 30-04-2021 & Memo No-622-ISS/2M-22/2020 dated 01/05/2021 & Memo No. 486-CS/2021 dated 24.04.2021. As such the following persons violated the order during this pandemic situation. Moreover the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons were arrested on 28/06/2021 from 16:45 hrs to 17:35 hrs, after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S.

All the arrested accused persons are liable for prosecution U/S-269/188/34 IPC & 51 (1) (b) of Disaster Management Act, 2005.

As the offence is bailable, So all the arrested accused persons were released on bail after obtaining bail bond vide Joypur PS GDE No-1352 Date-28/06/2021.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S -269/188/34 IPC & 51 (1) (b) of Disaster Management Act, 2005. Copy of order attached herewith.
