Dear Sir,

This is to inform that at around 10.30 A.m on 18.05.2021, a vehicle with vehicle no. WB82B2740 while travelling from Adra to Kashipur in Adra-Kashipur Road in ~~Jurali~~ *Jurali* Area accidentally hit and damaged the Public property (1 no. Pole, associated AB Cable and other assecories). Neither the Driver nor the Owner of the vehicle intimated after such accident. As reported by local people this office, tried to contact the owner of the vehicle he ignored the call and finally switched off the mobile thus it was intimated to your office by above-referred letter under Sl no (1). *Also there is considerable delay in F.I.R due to consultation with higher official and time required by Mr. Tapan Das for payment of quotation.*  
The owner of the vehicle visited this office with ~~our~~ *our* office personnel and asked for time after intimation to your end as per action taken at your end but denied to clear the damaged amount as per the quotation.

Hence FIR needs to be raised against the Driver and Owner of the vehicle to recover the damage of Public property at this end as per Electricity Act 2003 under Section 135 - 1(c).

This is for your information and further necessary action, please.
