I SI Pratap Ch. Ojha of Kashipur PS, do hereby lodge suo-moto complaint against the arrested accused persons namely (1) Bimal Kr. Majhi (46 Years) S/o- Kushadhaj Majhi of Vill- Jorethole, PS- Chhatna, Dist- Bankura (2) Pratap Maji (34 Years) S/O Gangadhar Maji of Vill- Talsa, PS – Chhatna, Dist- Bankura (3) Khagen Bouri (34 Years) S/O Durjadhan Bouri of Vill- Duliaborh PS-Kashipur, Dist- Purulia (4) Rabindra Nath Besra (37 Years) S/O Raban Besra of Vill- Hannyagora PS- Hura, Dist- Purulia (5) Basudeb Mahato (25 Years) S/O Nilkamal Mahato of vill – Dabar, PS – Purulia(M), Dist- Purulia, (6) Sourav Deoghoria (24Years) S/o- Dilip Deoghoria of Vill- Talajuri, PS- Kashipur, Dist- Purulia, (7) Kamishan Mahato (19 years) S/o- Subal Mahato of Vill- Kudlung, PS- Hura, Dist- Purulia and (8) Sibram Mal (24 years) S/o- Chitta Mal of Vill- Kharbona, PS- Chhatna, Dist- Bankura, beg to state that today on 18.06.21 at about 15.15 hrs while I along with force were performing mobile duty under Kashipur PS area vide Kashipur PS CC No.- 1305/2021 dated 18.06.2021, then I found some persons are gathered at Rajbari More under PS- Kashipur without any reason and violated the Restriction order passed by state Government of West Bengal in order to contain spread of COVID -19 pandemic. Seeing the Police party all persons tried to flee away, but we were able to apprehend 08 (eight) of them. I asked the reason about their gathering in the locality, but they did not give any satisfactory answer as well as they did not wear any mask or any other clothing covering their mouth and nose in public place as per Govt. order vide No- 647-ISS/2M-22/2020 dated- 15.05.2021 read with No- 707-ISS/2M-22/2020 dated- 29.05.2021 and Order No- 753-ISS/2M-22/2020 dated- 14.06.2021 of the Government of West Bengal and they violated the order.

As such they have committed offence u/s – 188/34 IPC & 51 (b) of Disaster Management Act – 2005. Since the offence u/s – 188 IPC is cognizable and they did the offence in presence of Police. Hence, I arrested them after maintaining all guidelines of Hon'ble Apex Court regarding arrest. All the process of arrest was done in between 15:25 hrs and 16:00 hrs.

So, under the above circumstances I pray before your kind self that a case may kindly be started against the above noted 08 (eight) arrested accused persons namely (1) Bimal Kr. Majhi (46 Years) S/o- Kushadhaj Majhi of Vill- Jorethole, PS- Chhatna, Dist- Bankura (2) Pratap Maji (34 Years) S/O Gangadhar Maji of Vill- Talsa, PS – Chhatna, Dist- Bankura (3) Khagen Bouri (34 Years) S/O Durjadhan Bouri of Vill- Duliaborh PS-Kashipur, Dist- Purulia (4) Rabindra Nath Besra (37 Years) S/O Raban Besra of Vill- Hannyagora PS- Hura, Dist- Purulia (5) Basudeb Mahato (25 Years) S/O Nilkamal Mahato of vill – Dabar, PS – Purulia(M), Dist- Purulia, (6) Sourav Deoghoria (24Y
