Sub: To lodge FIR against owner and driver of Trackstar 536 (Blue Colour) Tractor having Registration No WB82E0457, Engine No NLD2DEJ0053, Chassis No M9KATABAALVD01443 along with trolley (without number plate) loaded with sand approx 70-75 Cft.

Sir,
In producing herewith, 01 (One) tractor i.e. (i) Trackstar 536 (Blue Colour) Tractor having Registration No WB82E0457, Engine No NLD2DEJ0053, Chassis No M9KATABAALVD01443 along with trolley (without number plate) loaded with sand approx 70-75 Cft (ii) 02 piece old Iron made "Belcha" having iron butt and (iii) 02 piece iron made "Dhama" before you.

The nub of the fact in a nutshell is that today on 23.06.21 at 09.25 hrs. I SI Jagannath Saha of Kashipur PS along with (i) C/793 Prasanta Kr Patra and (ii) NVF/678 Basudeb Char both of Kashipur PS, Dist - Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 771 Dtd - 23.06.2021 and C.C No. 1339/21 Dtd. 23.06.2021. During my mobile duty, I received a tip off at 14.45 hrs. that some persons were loading one tractor with sand from the river bed of Darkeswar River near Siulibari village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Darkeswar River and fled away from the spot. We rushed to the Tractor and detained the said tractor. We searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending Tractor. Hence, seized the above noted tractor along with trolley loaded with sand approx 70-75 Cft, 02 pieces old Iron made "Belcha" having iron butt and 02 pieces iron made "Dhama" and brought the said seized articles to Kashipur PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley for investigation.
